A Jordanian national, his family consists of his wife **Dr. SANA' ALI SHIQWARA**, and four children: **Dr. TAMARA, Dr. AHMAD, Dr. SARA and Dr. MOHAMMAD**.

During his first university stage, he used to study and work at the same time in simple jobs to meet his study and daily life needs. Since his graduation in 1977, he has worked as an accountant, a supervisor at poultry and chicken farms, a sales manager, a plant director, and finally in senior management in a shareholding company.

In 1984, he established "YAN" Company, which embodied the first letters of his name, his father's name, and family name, and he began his success with a small capital practicing general trade in the sectors of food, consumables, and industrial raw materials, development of lands and real estates, and agriculture, and then drugs and medical supplies.

The quality leap in his career as a businessman was almost like a radical transformation towards the life philosophy itself when he sensed that the use of capital in the fields of education at all levels, and scientific research in its various fields, would grant him the supreme human value to serve the community and the nation, rise them, and lead them towards their sought objectives, and legitimate goals. So, the Middle East University (MEU) was a new threshold he established in 2005, associated with the Motto "knowledge is power," exploring its local, Arab, and international oceans, instruments, and means through which challenges are plunged into so that the ships of the learners and graduates would sail into landlocked oceans of science and knowledge with determination, seriousness, commitment, and constant endeavor to learn.

However, the university nursing all of these values, principles, and supreme ideals should entrench its strength elements through the quality of outputs, governance standards to which the universities joined under the Arab Universities Union were called for, and be adopted as the basis for good management established on partnership, transparency, and accountability, and to undertake unanimously by all the task of presiding its General Secretariat, which takes from the university its permanent Headquarters.

Dr. Nasereddin's vision led him to internationalize education and scientific research, directing the university into two important courses, the first was to transform its campuses into ones with international standards, and the second was to enter into contracts with international prestigious universities. Thus, his



idea succeeded on the ground to the extent that it now nurses the programs of two British universities, Bedfordshire and Strathclyde, in Bachelor's, Master's, and Doctoral degrees.

For that, he pursued postgraduate studies to obtain a Master's and a Doctorate in Business Administration and Strategic Planning Fields, alongside his wife, daughters, and sons in various majors. Dr. Nasereddin's true goal was to empower himself and family to know about scientific research methods, university management, and teaching skills, as well as anything related to higher education systems, and to draw education routes towards the requirements of development and labor mark.

As a result, His Majesty Abdulla II Bin Al-Hussein, early 2022, appointed Dr. Nasereddin to the Royal committee to modernize the political system with a membership in the youth empowerment committee being the closest to university students in expressing their desire to participate in decision making, through their involvement in national programmatic parties, and proper exercise of democracy and human rights. During this course, he wrote a number of books on thinking, planning, strategic management, and good governance, and lectured on their cases at a number of military and civil universities and colleges.

In appreciation of the services he provided to his country, his Jordanian community, and his nation His Majesty the Hashemite King Abdullah II Ibn Al-Hussein, may God protect him, chose him as a member of the Jordanian Senate on October 30, 2022, to continue his giving through the tasks of the Council and its various committees.

And what is being published now of studies in peer-reviewed journals, in addition to articles that have been published and continue to be published in Jordanian newspapers "AL-RAI, ADDUSTOUR, AL-GHAD" in which many subjects of interest to Jordan public opinion were addressed express his message to adopt strategic thinking and wisdom as a foundation for understanding, analyzing, and finding appropriate solutions for them.

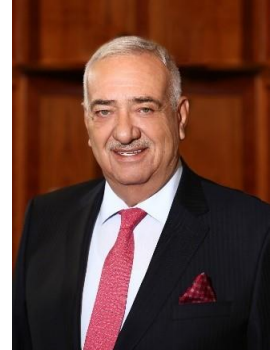
